This letter is to notify you of a proposed Comprehensive Plan amendment in the City of Bloomington. Pursuant to requirements of the Metropolitan Council, this letter serves as official notification that the proposed Comprehensive Plan amendment has been submitted to your agency for comment and review. The City of Bloomington is required to notify adjacent governmental units and school districts of proposed Comprehensive Plan amendments prior to submitting them for review by the Metropolitan Council.

The proposal is to amend the Comprehensive Land Use Plan for one parcel located at 8210 Highwood Drive, Bloomington, MN from Office to High Density Residential. The intent of the amendment is to accommodate a proposed expansion of the Friendship Village senior living community. The property owner proposes to construct a new health center and 94-unit residential living building at 8100 and 8210 Highwood Drive – See Figure 3. The applicant is Friendship Village of Bloomington.

FIGURE 1: General Location Map






FIGURE 2: Existing and proposed designations




EXISTING DESIGNATION
