We have owned our home at 1500- E 83rd St since 1972. Since the early 80's we have owned RV's. Starting with a tent trailer, then 2 class C's and since 1998 a 1993 25ft Class A. Over the last 15yrs or so we have applied and received a permit to park on the cement drive pad on the 15th Ave side of our property. Our neighbors have always signed for the permit except one. He will not sign anymore due to an incident with one of his dogs. Our RV is starting to show it's age and we are looking into purchasing a new one. We retired in 2018 and plan to continue to spend more time camping with our family and friends. We would now have to down size to a travel trailer 25" or less in length but would still have to park it on current pad. Our lot does not allow legal parking and the city has taken that into consideration when issuing us a permit. We are looking forward to our retirement and more time to enjoy camping. We are currently on hold with the purchase of a travel trailer until this issue is resolved. We also agree that the permit process is expensive and time consuming for the city.

PL2019-16 RV Ordinance Comments:

I have lived at 9817 Pillsbury Ave since 1975. I have been parking and storing a type II RV in my driveway more than 8 feet in front of the house since 1980.

I have had an RV permit to park and store an RV in my driveway more than 8 feet in front of the house and a waiver of screening requirements. I see no reason to change the current RV permit process. My neighbors have always approved my applications and have never objected to parking and storing the RV in the driveway. In fact, some neighbors have wondered why the RV permit is even needed.

The current RV permit process allows for the respect of the rights of adjacent neighbors, they have the ability to not approve the application. It is not necessary to prohibit everyone from storing an RV in their driveway if their neighbors have no objections.

Please keep the current RV permit process. The adjacent neighbors are the ones most affected by the RV, let them be the ones to decide with the RV permit process.

In addition to the provision allowing for temporarily parking in the driveway for loading and unloading, please add a provision that allows for temporarily parking an RV in the driveway for maintenance tasks like winterizing, de-winterizing, cleaning, washing, etc.

Please don't make the RV Ordinance so restrictive that it makes it impossible for me to use my RV, and enjoy my hobby.

Subject: RV proposed ordinance

Sirs:

I have the following concerns with the proposed RV ordinance.

1. I currently have an RV permit
2. I own a 16 foot fishing boat
3. I have / use off site, off season storage for the boat, typically October through May 4. I fish typically May through October 5. Many fishing outings happen after work hours and depend on the weather 6. Living near Hillcrest school, out home has a drive under garage due to the hill on our property 7. Due to the change in elevation between the front of the yard and the back, there is no vehicle access to the side yard or back yard 8. Driveway parking for my boat is my only option.
9. Doing away with the permit, coupled with the wording of the proposed ordinance removes my only legal boat parking option

I believe we need to provide an option to people who do not have parking options on property locations as diagramed in the proposed ordinance.
