Proposal for Development Application for 7101, 7001, 6925 W. 78th Street

Combine three parcels located at 7101, 7001, and 6925 W. 78th Street into one platted lot and one outlot. ALTA boundary survey and title commitments for the existing parcels are attached, along with the proposed plat. In connection with the plat, we are correcting the location of the W. 78th Street right of way and sidewalk easements on the 7001 parcel. The plat will dedicate W. 78th Street in its correct alignment. In addition, the sidewalk easements across the three parcels were created at different times through a number of documents. In connection with the plat, we are proposing to consolidate all of these sidewalk easements in one recorded easement. The proposed plat shows this. The required vacation request is being made concurrently with this plat request.
