On May 20, 2019, at its regular meeting, the Bloomington City Council enacted an Ordinance (No. 2019-27) approving the attached ordinance vacating various easements and right-of-way within and adjacent to 8030, 8040, 8049, & 8050 Morgan Circle, 1901 & 1950 American Blvd. West, & 8000 Knox Avenue South. The specific title of the ordinance enacting was: "AN ORDINANCE TO VACATE VARIOUS PUBLIC EASEMENTS AND RIGHT OF-WAY WITHIN AND ADJACENT TO OUTLOT A, HAYS PENN AVENUE ADDITION, LOTS 1, 2, AND 3, BLOCK 1, HAYS PENN AVENUE 2ND ADDITION, LOT 2, BLOCK 1, HAYS PENN AVENUE 3RD ADDITION, LOT 4, BLOCK 1, HAYS PENN AVENUE 4TH ADDITION, LOTS 1 AND 2, BLOCK 1, HAYS PENN AVENUE 6TH ADDITION, AND LOT 1, BLOCK 2, PENN AMERICAN ADDITION."
