Mayor Benedict led the Council and the audience in the pledge of allegiance to the flag.

Present: Mayor Benedict, Councilmen C. Allen, J. Anderson, W. Belanger, R. Darr, J. Malone and

J. 0'Neil. The Council was requested to consider authorizing the advertisement for bids for printing

of a Bicentennial pamphlet by the Promotion and Development Commission. Specifications for this pamphlet were prepared by the Advertising Committee of the P & D Commission and copies were sent to the Council with the agenda material.

The proposed schedule would be as follows:

Cecil Nelson of the Advertising Committee of the Promotion and Development Commission displayed the layout for the pamphlet and explained the information proposed to be included.
