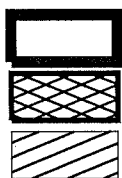
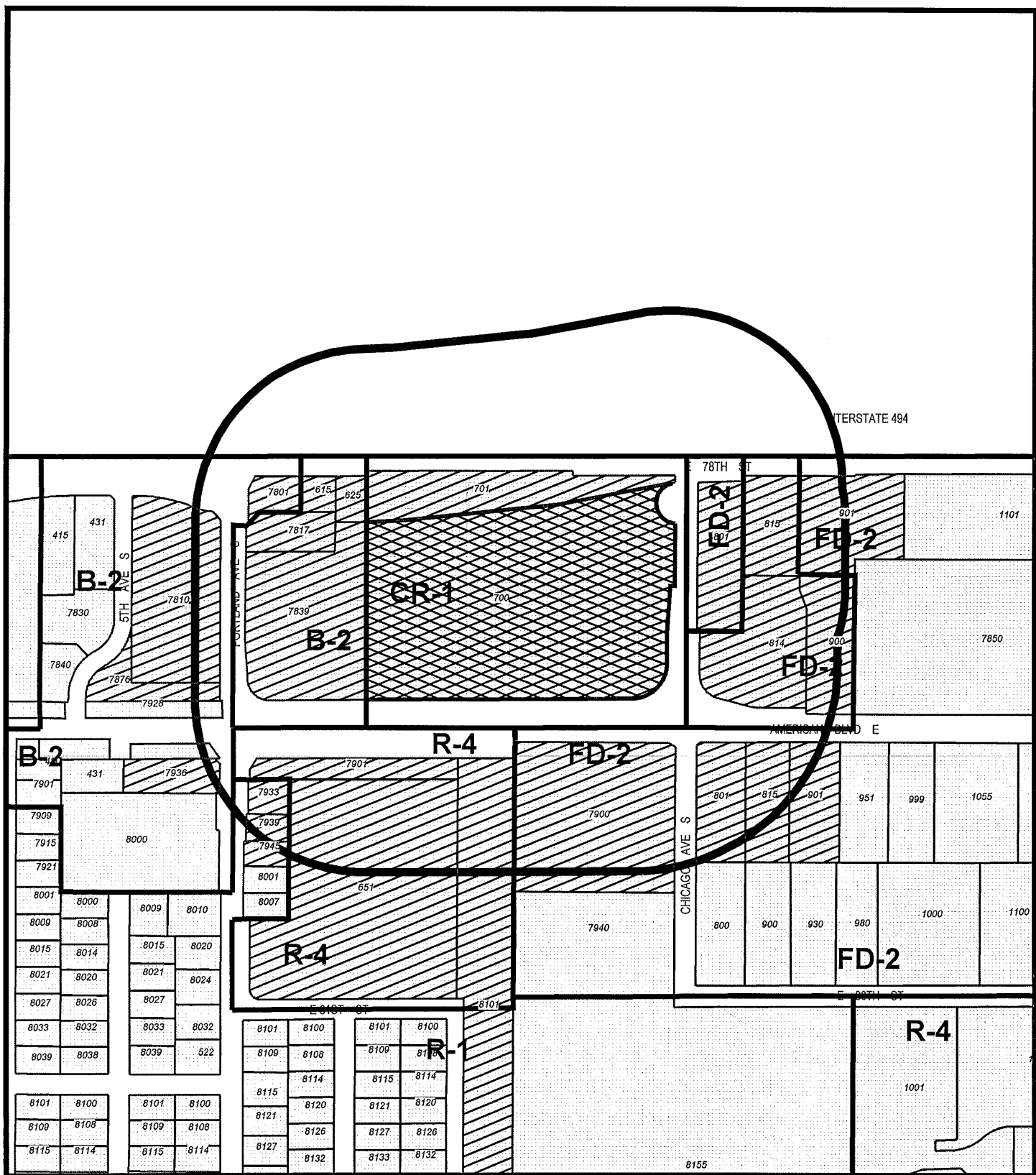

City of Bloomington Notification Map

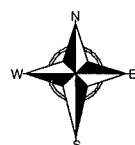
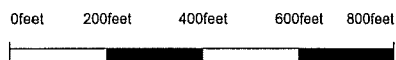


Notification Boundary
