

-YOUR 9 MONTH NOTICE OF CLOSING- CLOSURE STATEMENT

YOU ARE NOTIFIED, that pursuant to Minnesota Statutes section 327C.095 and Bloomington, Minnesota Code of Ordinances section 14.550.01, the manufactured home park generally known as Southgate Mobile Village (the "**Park**"), located at 8701 Lyndale Avenue South Bloomington MN 55420, will close and will no longer be used as a manufactured home park effective as of May 31, 2017 (the "**Closure Date**"). This closure is not related to a sale of the property. All residents of the Park must vacate the Park and remove their manufactured home and any other personal property by the Closure Date or the date their respective lease or residency agreement is lawfully terminated; provided that no resident in good standing will be required to vacate the Park until sixty (60) days after the conclusion of the public hearing regarding this park closure that will be held by the Bloomington City Council on a date that will be announced by the City.

YOU MAY BE ENTITLED TO COMPENSATION FROM THE MINNESOTA MANUFACTURED HOME RELOCATION TRUST FUND ADMINISTERED BY THE MINNESOTA HOUSING FINANCE AGENCY.
