- 1) The applicant is proposing a Petco animal supply store within the Southtown Shopping Center. The retailer would be located immediately west of Schuler shoes in currently vacant space.
- 2) By Code, the retail establishment is a pet services facility. Currently, pet services facilities are not permitted in the C-3 district Southtown Shopping Center is located on parcels zoned C-3. The applicant has submitted a privately-initiated Code amendment to allow pet services facilities as a conditional use within the C-3 district.
- 3) The Planning Commission is holding a public hearing on the Code amendment December 8, 2016. The anticipated date for a City Council public hearing is December 19th.
- 4) Apart from small animals, are any dogs and cats boarded on-site until adoption? How are on-site adoption events managed? Are the animals brought to the site during business hours and then returned to another location?
- 5) The anticipated CUP triggers compliance with Section 19.52, interior trash and recycling. Identify an interior trash facility on the floor plan and specify how animal waste will be managed.
- 6) Please identify location(s) of bike racks available to shoppers. Are there bike racks conveniently located relative to the proposed Petco? If not, identify where additional bike racks may be located.
