To Whom It May Concern:

On behalf of Celco Partnership and its controlled affiliates doing business as Verizon Wireless (Verizon Wireless), Terracon is writing to invite your comment on the effect of the above-referenced project on historic resources within the project's 0.5-mile Area of Potential Effects (APE) that are eligible for the National Register of Historic Places. We are requesting your review pursuant to Section 106 of the National Historic Preservation Act, the Advisory Council on Historic Preservation's Regulation for compliance with Section 106, the Nationwide Programmatic Agreement on the Collocation of Wireless Antennas (adopted March 16, 2001), and the Nationwide Programmatic Agreement, effective March 7, 2005.

Field assessment for both historic properties and archaeological sites will be conducted, and a determination will be made of the project's direct and indirect effects on eligible properties. Consulting parties are invited to provide information concerning historic or archaeological properties already listed in the National Register or that could be eligible for listing in the National Register.

Verizon Wireless is proposing to construct a ballasted telecommunications tower located at 10834 Louisiana Avenue S in Bloomington, Hennepin County, Minnesota (44 deg 48 min 25.41 sec N, 93 deg 22 min 28.93 sec W). The project involves the construction of a ballasted tower with an overall height (including attachments) of 30-feet and associated small cell equipment, located in a paved parking lot.

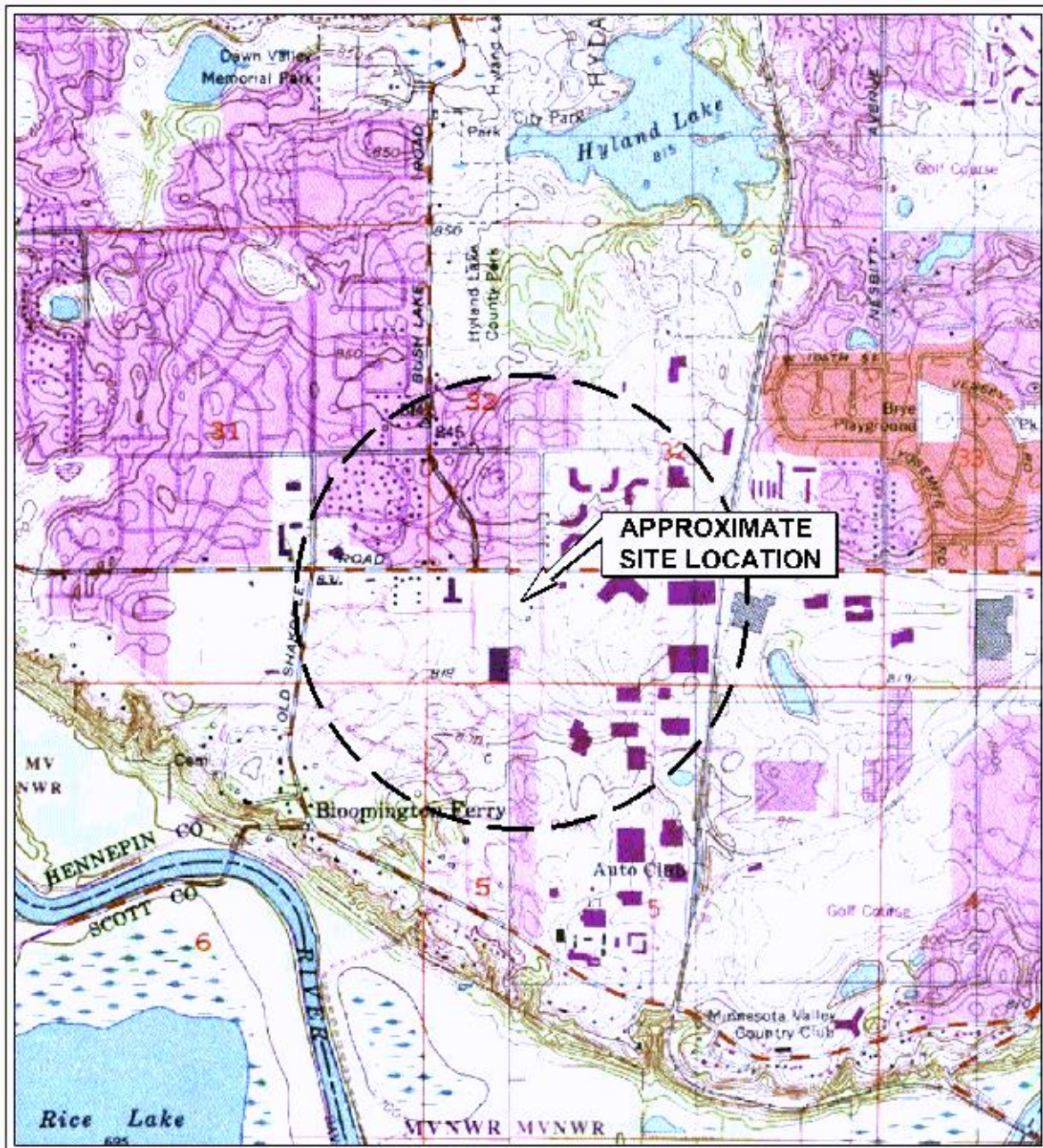
