## EASEMENT / RIGHT-OF-WAY VACATION APPLICATION BLOOMINGTON CENTRAL STATION 7<sup>TH</sup> ADDITION

The Preliminary and Final Plat (Type III) of BLOOMINGTON CENTRAL STATION 7<sup>TH</sup> ADDITION was approved by the Bloomington City Council on May 3, 2021. April 2021. - Easement for Sidewalk and Bikeway Purposes per Doc. Nos. A9301757 and 7788234

  - A portion of this easement at future Outlot C, BLOOMINGTON CENTRAL STATION 7TH ADDITION will be vacated
  - The remainder of this easement will remain on Outlot B, BLOOMINGTON CENTRAL STATION 7TH ADDITION
- Drainage and Utility easement per BLOOMINGTON CENTRAL STATION 2<sup>nd</sup> ADDITION
