AN ORDINANCE TO VACATE DRAINAGE, UTILITY, SIDEWALK, BIKEWAY, VEHICULAR PARKING, DRIVEWAY AND MANEUVERING EASEMENTS OVER AND ACROSS OUTLOTS
B, R, AND T, BLOOMINGTON CENTRAL STATION 2ND ADDITION, LOT 2, BLOCK 1, VTC ADDITION, PARCEL 97-11, AND PARCEL 97-10

The City Council of the City of Bloomington, Minnesota hereby ordains:

Section 1. That the following easements are hereby vacated:

All drainage and utility easements within Outlots R and T, BLOOMINGTON CENTRAL STATION 2ND ADDITION, according to the recorded plat thereof, Hennepin County, Minnesota, as dedicated in said plat.
