Purpose of Vacation: Clear the title for re-platting of the property.

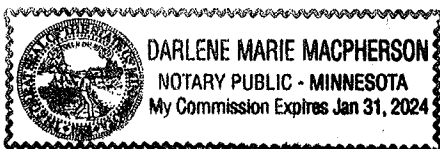
