AN ORDINANCE TO VACATE DRAINAGE, UTILITY, SIDEWALK, BIKEWAY, AND STREET EASEMENTS **OVER AND ACROSS OUTLOT I, BLOOMINGTON CENTRAL STATION AND** OUTLOTS K, U, AND V, **BLOOMINGTON CENTRAL** STATION 2ND ADDITION

The City Council of the City of Bloomington, Minnesota hereby ordains:

Section 1. That the following easements are hereby vacated:

That part of an easement for sidewalk, bikeway, and utility purposes over and across Parcel No. 97-11, as described in Document No. 7788234, filed of record in the Office of the County Recorder, Hennepin County, Minnesota, lying within Outlot V, BLOOMINGTON CENTRAL STATION 2ND ADDI-TION, Hennepin County, Minneso-

Section 2. This vacation shall not be effective until the plat of BLOOMINGTON CENTRAL STATION 8TH ADDITION (in which the above described properties are being platted) is filed of record with the Office of the County Recorder, County of Hennepin.

Section 3. That the Mayor and City Manager are hereby authorized to execute any documents which may be necessary to carry out the vacation described in Section 1 above.
