A RESOLUTION INITIATING REZONING OF MULTIPLE PARCELS IN THE CITY OF BLOOMINGTON, MINNESOSTA AROUND THE INTERSECTIONS OF LYNDALE AVENUE SOUTH WITH WEST 86TH STREET AND WEST 98TH STREET, FROM THE GENERAL COMMERCIAL (B-2) ZONING DISTRICT TO THE NEIGHBORHOOD COMMERCIAL CENTER (B-4) ZONING DISTRICT

WHEREAS, the City Council of the City of Bloomington is the official governing body of the City of Bloomington, Minnesota ("City"); and

WHEREAS, the City adopted the Lyndale Avenue Suburban Retrofit Plan ("Retrofit Plan") on April 5, 2021; and

WHEREAS, the subject parcels shown in the attached exhibit are identified in the Retrofit Plan as part either the 86th Street Node or 98th Street Node; and

WHEREAS, the subject parcels are currently zoned General Commercial (B-2); and

WHEREAS, the B-2 Zoning District does not allow residential development; and

WHEREAS, the Retrofit Plan found that adding residential options and density within the areas of the 86th Street Node and 98th Street Node is important to catalyzing the type of development envisioned along the Lyndale Ave South corridor; and

WHEREAS, a priority action of the Retrofit Plan is that the City rezone parcels shown in the attached exhibit to the B-4 Zoning District.

NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF BLOOMINGTON IN REGULAR MEETING ASSEMBLED, that the City Council directs staff to bring forward for consideration at a public hearing, after notification of the affected and surrounding property owners and the review and recommendation of the Planning Commission, an ordinance rezoning the following parcels from the General Commercial (B-2) Zoning District to the Neighborhood
