The City Council of the City of Bloomington, Minnesota hereby ordains:

Section 1. That the following easements are hereby vacated:

That part of an easement for drainage and utility purposes as dedicated within Lot 3, Block 1, SICK, according to the recorded plat thereof, Hennepin County, Minnesota, described as the east 5.00 feet of said Lot 3, lying south of the north 5.00 feet and north of the south 17.00 feet of said Lot 3.

That part of an easement for drainage and utility purposes as dedicated within Lot 4, Block 1, SICK, according to the recorded plat thereof, Hennepin County, Minnesota, described as the west 5.00 feet of said Lot 4, lying south of the north 5.00 feet and north of the south 17.00 feet of said Lot 4.

Section 2. That the Mayor and City Manager are hereby authorized to execute any documents which may be necessary to carry out the vacation described in Section 1 above.
