Thank you Nick, here is a general project description:

Existing 2.3 acre site has a four story with underground parking garage structure and is a through lot between Cedar Avenue and Old Shakopee Road. There are 47 apartment units composed of 5 studio units, 24 one bedroom units, and 18 two bedroom units. The existing site meets the required number of parking stalls including 45 surface stalls and 47 enclosed stalls.

This proposal is for the construction of a four story with underground parking garage structure directly to the east of the existing building. There will be 32 apartment units, composed of 15 one bedroom units and 17 two bedroom units. There will be 67 new parking stalls, including 17 surface stalls and 50 enclosed stalls.

We plan on submitting to have the site rezoned to a RM50 classification.

The density of the site will be 34.3 units/acre (47 + 32 = 79/2.3)

The areas of the proposed apartment units will be 1060 square feet for the two bedroom units and 675 square feet for the one bedroom units.


The project would like to proceed with construction this fall.
