CITY OF BLOOMINGTON **ORDINANCE NO. 2024-26**

AN ORDINANCE TO VACATE DRAINAGE AND **UTILITY EASEMENTS** OVER AND ACROSS .OTS 1 AND 2, BLOCK 1, LEE STAMPING 1ST ADDITION

The City Council of the City of Bloomington, Minnesota hereby ordains: Section 1. That the following easements are hereby vacated:

All drainage and utility easements as dedicated within Lots 1 and 2, Block 1, LEE STAMPING 1ST ADDITION, according to the recorded plat thereof, Hennepin County, Minnesota, as dedicated in said plat.

That part of an easement for utility purposes over and across Lots 1 and 2, Block 1, LEE STAMPING 1ST ADDITION, as described in Document No. 3299828, filed in the office of the County Recorder, Hennepin County, Minnesota.

That part of an easement for utility purposes over and across Lots 1 and 2, Block 1, LEE STAMPING 1ST ADDITION, as described in Document No. 3595850, filed in the office of the County Recorder, Hennepin County, Minnesota.

Section 2. This vacation shall not be effective until the plat of BLOOMINGTON 46TH ADDITION (in which the above described property is being platted) is filed of record with the Office of the County Recorder, County of Hennepin.

Section 3. That the Mayor and City Manager are hereby authorized to execute any documents which may be necessary to carry out the vacation described in Section 1 above.
