The following items are needed as soon as possible to proceed with the timely filing of the final plat at Hennepin County:

1. Two (2) mylar copies of the plat
2. Updated PDF copies of the preliminary and final plat that reflects City and County comments for needed revisions.
3. Signed deeds for easements to be filed with Hennepin County. (Will follow in a separate email).
4. \$15 fee for Certified copy of plat
5. A private common driveway/access easement agreement must be provided as approved by the City Engineer (amend Document No. 3511671 to include the new description/owner of proposed Lot 1).
6. A private common utility easement agreement must be provided as approved by the City Engineer.
7. A signed Conditional Approval for Encroachment must be provided.
