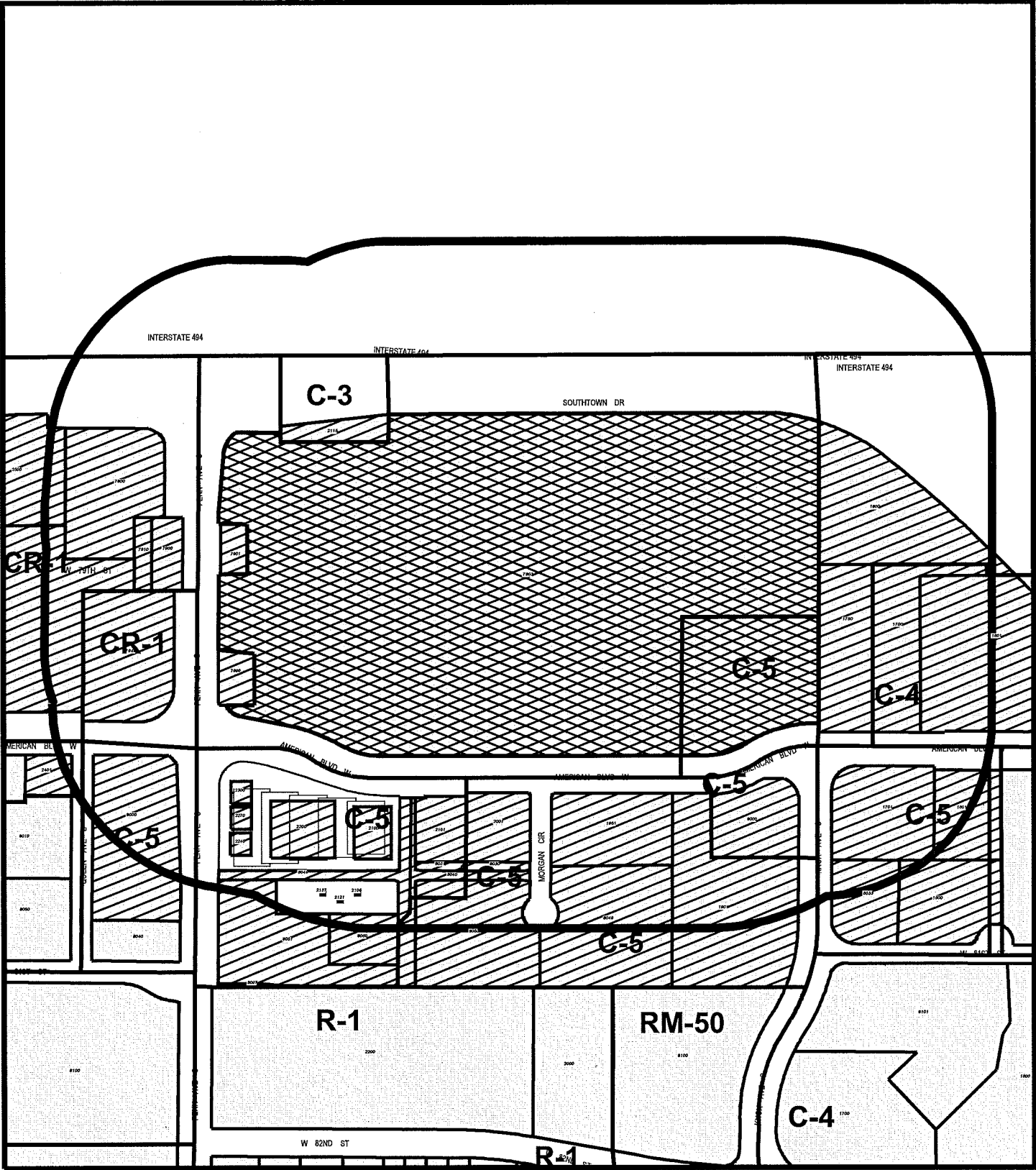

Notification Boundary

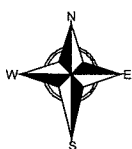
