CITY OF BLOOMINGTON ORDINANCE O. 2020 - 41 AN ORDINANCE TO VACATE PART OF A DRAINAGE AND UTILITY EASEMENT OVER AND ACROSS LOT 1, BLOCK 1, CY- PRESS SECOND ADDITION

The City Council of the City of Bloomington, Minnesota hereby ordains:

Section 1. That the following easements are hereby vacated:

That part of an easement for drainage and utility purposes as dedicated in the record plat of CYPRESS SECOND ADDITION, Hennepin County, Minnesota, described as follows:

Commencing at the most northerly corner of said Lot 1; thence on an assumed bearing of South 89 degrees 33 minutes 13 seconds East, along the north line of said Lot 1, a distance of 292.47 feet; thence South 00 degrees 00 minutes 24 seconds East a distance of 49.10 feet to the point of beginning; thence South 00 degrees 00 minutes 24 seconds East a distance of 57.40 feet; thence North 85 degrees 37 minutes 43 seconds West a distance of 23.59 feet; thence North 04 degrees 22 minutes 17 seconds East a distance of 7.64 feet; thence North 26 degrees 45 minutes 32 seconds East a distance of 28.45 feet; thence North 63 degrees 22 minutes 22 seconds West a distance of 9.27 feet; thence North 26 degrees 37 minutes 38 seconds East a distance of 24.77 feet; thence South 63 degrees 04 minutes 02 seconds East a distance of 8.21 feet to the point of beginning.

Section 2. That the Mayor and City Manager are hereby authorized to execute any documents which may be necessary to carry out the vacation described in Section 1 above.
