BOULEVARD, FLOODAGE
AND MAINTENANCE
EASEMENTS OVER
AND ACROSS LOT 1,
BLOCK 1, NINE MILE
WEST 2ND ADDITION

The City Council of the City of
Bloomington, Minnesota hereby

Section 1. That the following
easements are hereby vacated:

maintenance purposes over and
across Lot 1, Block 1, NINE MILE

record in the Office of the County
Recorder, Hennepin County, Min-
nesota.

An easement for sidewalk and
boulevard purposes over and
across Lot 1, Block 1, NINE MILE
WEST 2ND ADDITION, as described
in Document No. 3925442 filed of
record in the Office of the County
Recorder, Hennepin County, Min-
nesota.

An easement for drainage and
utility purposes over and across Lot
1, Block 1, NINE MILE WEST 2ND
ADDITION, as described in Docu-
ment No. 3925443 filed of record in
the Office of the County Recorder,
Hennepin County, Minnesota.

Section 2. This vacation shall
not be effective until the plat of
NINE MILE WEST 4TH ADDITION (in
which the above-described proper-
ty is being platted) is filed of record
with the Office of the County Re-
corder, County of Hennepin.

which may be necessary to carry
out the vacation described in Sec-
tion 1 above.
