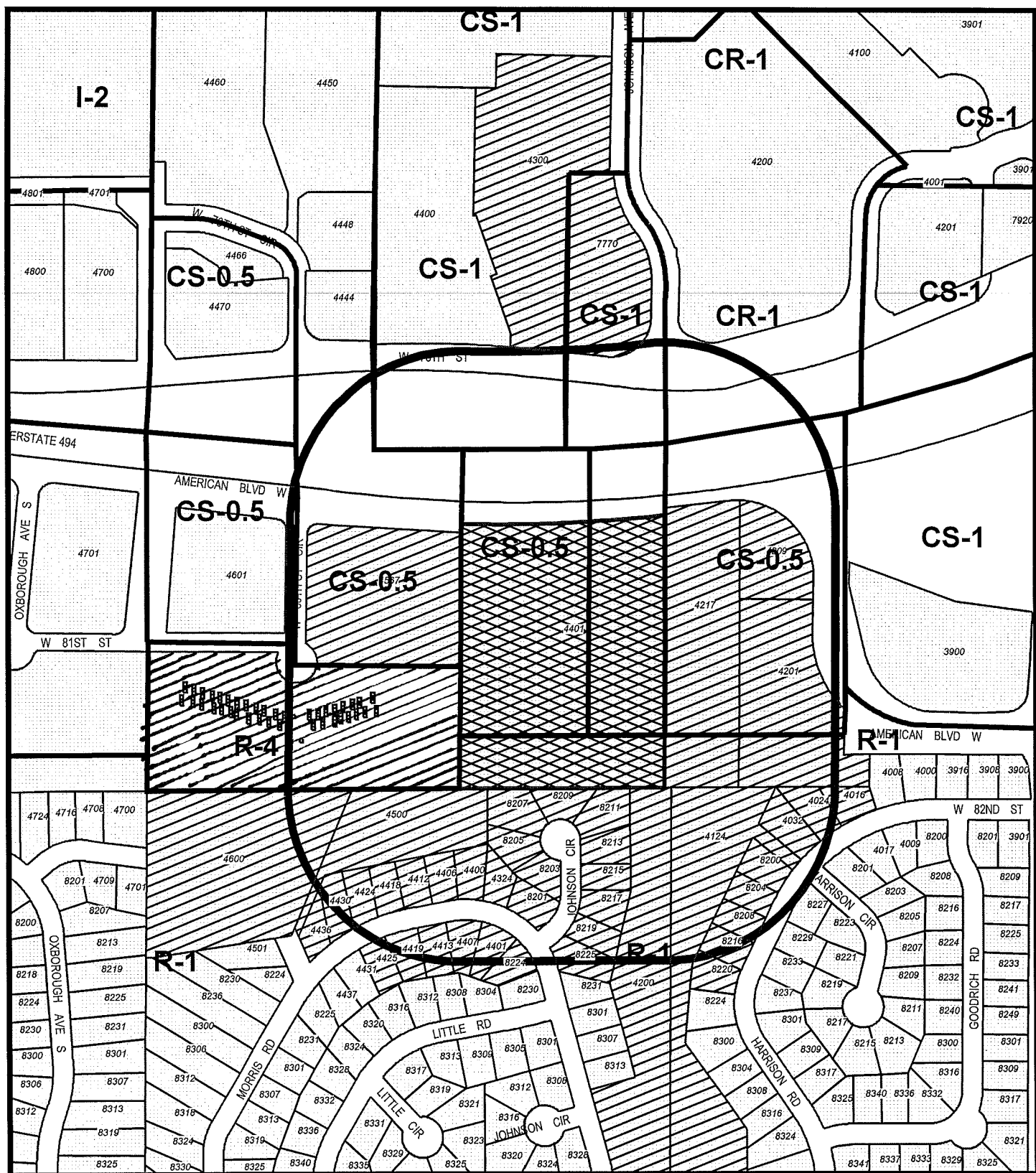

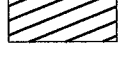

City of Bloomington Notification Map



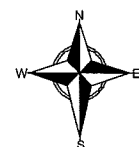
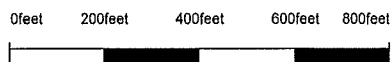
-  Notification Boundary

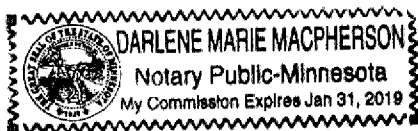
