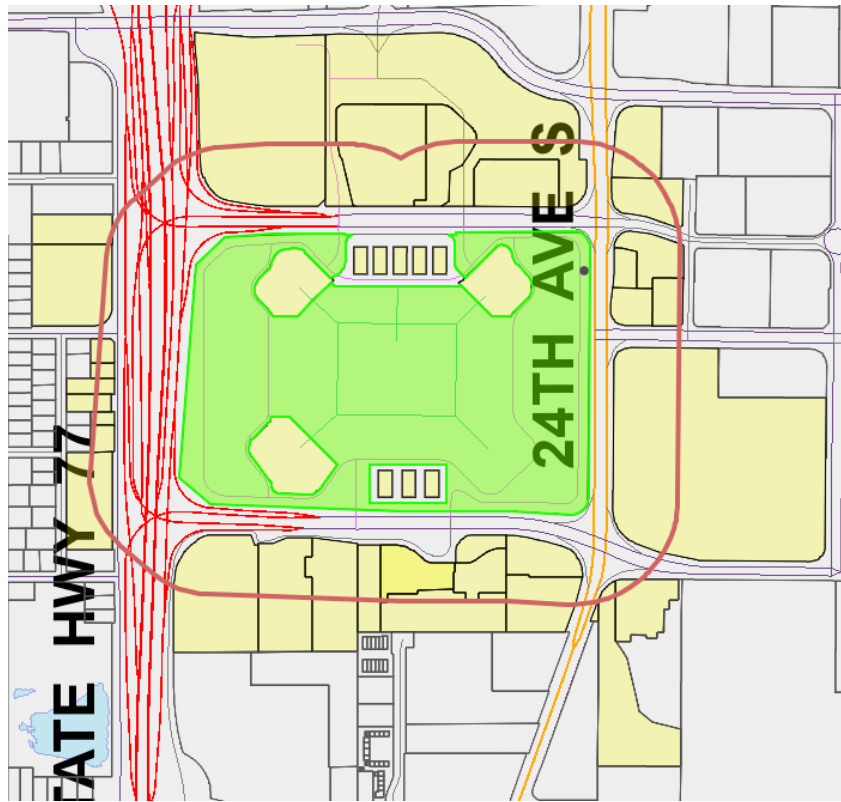





## City of Bloomington Notification Map
