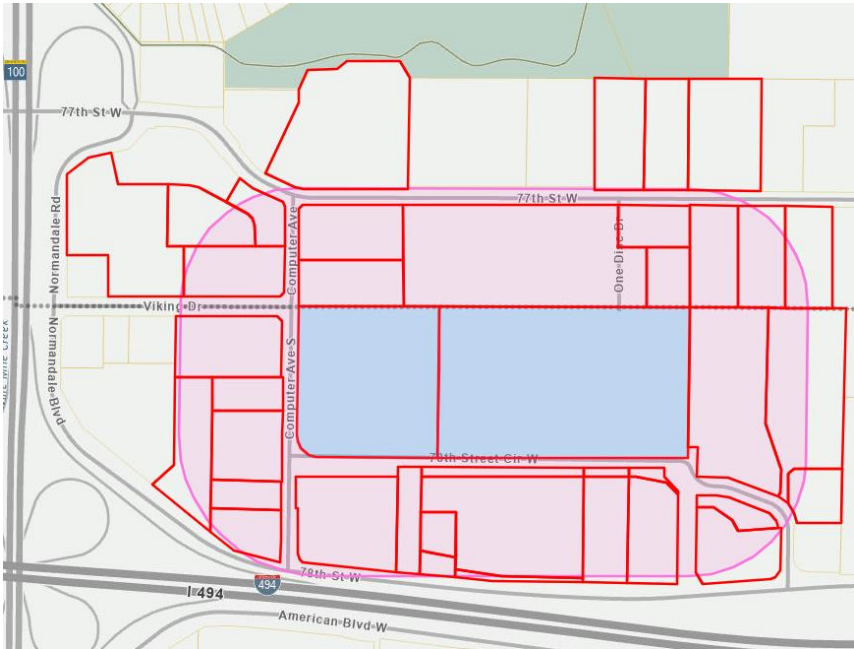





City of Bloomington Notification Map
